- Episcopal Fund Collection Rate 59.4% vs. 60.9% in 2024
- World Service Collection Rate 57.4% vs. 49.0% in 2024
- General Administration Collection Rate 56.8% vs. 51.0% in 2024
- First quarter of 2024 Collections included \$3.7 million for disaffiliating churches.

- The month of November 2025 is 46% lower compared to 2017, 26% lower compared to 2023 and 9% lower compared to 2024. Churches started disaffiliating in February 2019.
- Total 2025 apportionments allocated to the Annual Conferences are 41% less compared to 2018 and 32% less compared to 2024.
- In 2021, it appears that some of the annual conferences paid based on the proposed budget to the 2020 General Conference rather than the actual apportionments.

- Overall Collection Rate = 44.4% vs. 36.2% in 2024
- 9 Episcopal Areas paid equal or more than 91.7% of their apportionments (5 in Africa, 3 in Europe and 1 in the Philippines)
- 8 Episcopal Areas paid less than 91.7% of their apportionments (5 in Africa, 1 in Europe and 2 in the Philippines)
- 4 Episcopal Areas in Africa did not pay any apportionments.
- The apportionments for the newly established Episcopal Areas of Burundi-Rwanda and Tanganyika were added to the total apportionments. Total number of Episcopal areas in 2025 is 21 vs. 20 in 2024.
- Eurasia separated from the United Methodist Church on April 3, 2025. We received its last contribution in March 2025.
