

Overview and Membership

¶¶ 611 & 612

 Each conference shall have a council on finance and administration

¶ 612.2

Need to have 5 to 21 voting members plus Ex officio members

¶ 612.4

 Members shall not vote on matters that directly or indirectly affect theirs or their families, business, income or employment.

Amenability and Relationships

¶¶ 612.6 & 612.7

- Council reports directly to the annual conference.
- Must cooperate with the Council on ministries in developing the benevolence budget.

Responsibilities

- 1. Recommend to the annual conference budgets for income and expenditures for all funds
- 2. Recommend to the annual conference proposals to raise capital funds and proposals before the conference
- 3. Recommend to the annual conference the local church apportionment formulas.

Responsibilities (cont'd)

- 4. Provide information to have leaders understand and support the conference budget.
- 5. Develop policies governing the investment of conference funds.
- 6. Recommend procedures on the theology of giving.
- 7. Advise local churches on making their facilities and programs accessible.

Responsibilities (cont'd)

- 8. Recommend procedures when budgeted funds are inadequate
- 9. Review at least quarterly, the budget to actual expenditures
- 10. Recommend to the annual conference the conditions for borrowing funds
- 11. Authority and supervision over the conference treasurer
- 12. Designates the conference treasury as the central treasury for all conference agencies

Responsibilities (cont'd)

- 13. Establish policies and practices in the employment and compensation of personnel
- 14. Promote and standardize financial recording and reporting at the local church
- 15. Provide leadership and training for business administration in the local churches
- 16. Recommend plans to initiate a foundation

Responsibilities (cont'd)

- 17. Perform other administrative and fiscal functions as the annual conference may assign
- 18. Ensure no apportioned conference funds are spent on the use of alcoholic beverages
- 19. Honoring our commitment to the inclusion of all people in the life of the church

Budgets

- 1. Recommend to the annual conference
 - Clergy Support
 - ➤ Administrative budget
 - ➤ Conference benevolence budget
 - ➤ Other causes
 - ➤ Special appeals

Apportionments

- Study the effects of the proposed changes to the apportionment formula
- Apportion the General Conference apportionments to the local church
- The council shall make every effort for the full payment of these apportionments as part of the Church's shared financial covenant


¶ 616 - Depository

Designate a depository for conference funds

¶ 617 – Auditing – Authority and Responsibility

- The accounts of the conference treasurer are to be audited.
- Require audit reports from all agencies receiving conference funds.
- Require audit reports from all districts.

¶ 619.1

 Receive & disburse remittances funds authorized by the General Conference

¶ 619.1.c)

The treasurer shall prepare financial statements and reports as required

¶ 619.1.c)(2)

 The treasurer shall provide a report of all funds under his or her direction and shall be printed in the conference journal

¶ 619.1.d)

Council funds may be invested according to policies and procedures

¶ 619.1.e)

 The treasurer shall provide counsel and guidance to local churches for standardized reporting

¶ 619.2

As Director of Administrative Services, may have other responsibilitie.

¶¶ 619 & 619.3

The Council on Finance and Administration shall have authority and supervision over the Treasurer / Director of Administration, and will determine their responsibilities
